Creativity: 20%

Does recipe show originality? Is this recipe reflective of unique twists to ingredient usage? Have you incorporated your personal touch to this recipe?

Wild Card: 20%

Does this recipe have easy to find everyday ingredients and is it easy to make? Does the recipe support healthy eating? Does this recipe have a story that will inspire others to make it? What makes this recipe unique and/or special?
